### NOTICE TO THE MEMBERS

Members of the Company are hereby informed that pursuant to Section 108 and Section 110 of the Companies Act, 2013, ('the Act') read with Companies (Management & Administration) Rules, 2014, (including any statutory modification or re-enactment thereof for the time being in force), the Postal Ballot Notice and Explanatory Statement thereto along with Postal Ballot Form seeking consent of members through Postal Ballot, including voting by electronic means (e-voting) have been dispatched to the members whose names appear in the Register of Members / Beneficial Owners as on Friday, 3<sup>rd</sup> February, 2017 (being cut-off date) on the following resolutions:

1. Special Resolution for sell, transfer, dispose of CATV Business of the Company into Hathway Datacom Central Private Limited, wholly owned subsidiary company, pursuant to section 180 (1)(a) of the Companies Act, 2013 by way of Slump Sale.
2. Special Resolution for rescinding the earlier resolution passed at the Court Convened Meeting of Equity Shareholders of the Company on Saturday, October 15, 2016 for demerging the Broadband business of the Company into Hathway Broadband Private Limited.

The Board of the Directors of the Company has appointed Mr. Himanshu S. Kamdar, Partner, M/s. Rathi & Associates, Practicing Company Secretaries (Membership No. 5171), to scrutinize the e-voting process and postal ballot in a fair and transparent manner.

The Company has completed the dispatch of Postal Ballot Notice, along with the Postal Ballot Form and a self-addressed postage prepaid Business Reply Envelope to the members on Friday, February 10, 2017. The detailed instructions and information relating to e-voting are set out in the Postal Ballot Notice sent to Members.

The voting rights of Members shall be reckoned on the paid-up value of shares registered in the name of the member(s) as on cut-off date. A person who is not a Member as on the cut-off date should treat this notice for information purposes only. Notice and Explanatory Statement together with the specimen of postal ballot form and all the details pertaining to e-voting shall also be available on the Company's website (www.hathway.com).

Members holding shares in physical/dematerialized form have an option to vote either electronically or through Postal Ballot form. Members can opt for only one mode of voting i.e. either by Postal ballot form or by electronic mode. In case any member casts vote through Postal ballot as well as electronic mode, then voting done through electronic mode shall prevail and voting done through postal ballot will be treated as invalid.

Members are requested to note that:

1. In case the members are voting by way of Postal Ballot form, the said form duly completed and signed should reach the Scrutinizer on or before the close of working hours i.e. **5.00 p.m. on Sunday, 12<sup>th</sup> March, 2017**. All postal ballot forms received after the said date will be treated as invalid as if no reply from such Member has been received.
2. In case the members are opting for e-voting, they can cast their vote online i.e. from **Saturday, 11<sup>th</sup> February, 2017 at 10.00 am** which ends on **Sunday, 12<sup>th</sup> March, 2017 at 5.00 pm**. Please note that the e-voting module will be disabled for voting thereafter.
