Textual Information()	During FY 18-19, JCDHPL, JIDHPL & JCBHPL (Acquirers) acquired sole control of the Company pursuant to:(i) Acquisition of 90,88,10,000 equity shares representing 51.34%; and (ii) Acquisition of further 20.61% equity shares pursuant to the open offer. The Board of Directors of the Company had approved a scheme of arrangement inter alia for the amalgamation of the Company with Network18 Media & Investments Limited (Network18) and the same was filed with BSE & NSE on February 20 and February 21, 2020, respectively. In terms of the scheme, upon effectiveness of the scheme, the Company would cease to exist and Network18 would continue to be MPS compliant. The scheme has been returned by the stock exchanges on May 4 / May 5, 2020. The Company proposes to seek clarification from the stock exchanges in this regard and address their concerns, as applicable.
