Textual Information()	<p>To achieve compliance of 25% MPS (against 5.91% public shareholding), the Promoters had made an offer for sale of 33,79,83,855 equity shares representing 19.09% of the total issued and paid-up equity share capital of the Company, in accordance with the provisions of the applicable SEBI Circulars. The offer for sale was open for bidding by non-retail investors on March 26, 2021 and by retail investors on March 30, 2021. Out of 33,79,83,855 equity shares, 20,54,43,340 equity shares remained unsold in the offer for sale and were transferred from the Clearing Members (NSE Clearing Limited) demat account to the Promoters demat accounts on April 5, 2021. To reflect the correct shareholding pattern as on March 31, 2021, these 20,54,43,340 equity shares have been added to the Promoters holding in the shareholding pattern as on March 31, 2021</p>
Textual Information()	<p>During FY 2018-19, JCDHPL, JIDHPL &amp; JCBHPL (Promoters) acquired sole control of the Company through a preferential offer followed by an open offer. Consequently, the public shareholding fell below the minimum public shareholding (MPS) prescribed under the Securities Contracts (Regulation) Rules, 1957. To achieve compliance of 25% MPS (against 5.91% public shareholding), the Promoters had made an offer for sale of 33,79,83,855 equity shares representing 19.09% of the total issued and paid-up equity share capital of the Company, in accordance with the provisions of the applicable SEBI Circulars. The offer for sale was open for bidding by non-retail investors on March 26, 2021 and by retail investors on March 30, 2021. Pursuant to this offer for sale, effective March 30, 2021, the public shareholding of the Company has increased from 5.91% to 13.39%. The Promoters have informed the Company that they would undertake another offer for sale in accordance with the provisions of the applicable SEBI Circulars to achieve compliance with 25% MPS (against 13.39% public shareholding) in the immediate future.</p>
